2. Personal Data We Process

3. Purpose and Legal Basis for Processing

We process your personal data for the following purposes:

The processing of your personal data is based on your explicit **consent** (Article 6(1)(a) GDPR).

4. Special and/or Sensitive Personal Data

Our website and/or services are not intended for individuals under the age of 16 without parental or guardian consent. However, we cannot verify the age of our visitors.

We encourage parents to be involved in their children's online activities to prevent the collection of data without parental consent.

5. Automated Decision-Making

Joone Graphics does not make decisions based solely on automated processing that could produce legal effects concerning you or similarly significantly affect you.

6. Retention Periods for Personal Data

Specifically:

- Email addresses are retained for as long as you wish to receive our newsletter. You can unsubscribe at any time by following the instructions provided in our emails.

7. Sharing Personal Data with Third Parties

We only share your personal data with third parties when necessary to provide our services to you or to comply with legal obligations.

For sending newsletters, we securely store your email address with our mailing service provider MailBlue or Luma, depending the purpose of subscription.

We ensure that our partners comply with appropriate data protection obligations.

8. Cookies and Similar Technologies

We use cookies and/or similar technologies on our website to enhance your user experience.

9. Your Rights

You have the following rights regarding your personal data:
